

**Charlie's Car Wash
Summer Roadtrip 2023 Sweepstakes**

RULES, TERMS, AND CONDITIONS

1. **NO PURCHASE NECESSARY** TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

2. **Promotion Description:** The Charlie's Car Wash Summer Roadtrip 2023 Sweepstakes ("Sweepstakes") begins on May 1, 2023 AT 7:00 AM CDT and ends on June 30, 2023, AT 8:00 PM CDT. (the "Promotion Period").

3. **Sponsor:** The sponsor of this Sweepstakes is Charlie's Car Wash ("Sponsor"). By participating in the Sweepstakes, each Participant unconditionally accepts and agrees to comply with and abide by these Rules, Terms and Conditions ("Official Rules") and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes. Participants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. Sponsor may be reached by email at comments@charlies.com during the Promotion Period.

4. **Rules, Terms, and Conditions:** By entering, all participants agree to be bound by the Rules, Terms, and Conditions of the Promotion. All participants additionally agree to be bound by Charlie's decisions made in connection with this Promotion.

5. **Eligibility:** The Promotion is open to legal residents of the United States who are at least 21 years old (each, a "Participant"). Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (the "Promotion Entities"), are ineligible to enter the Sweepstakes or win the prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited or restricted by law.

6. **Prizes:**

1 - \$1,500 Prize (2 - \$500 Visa Gift Cards and 1 - \$500 Hotelgift.com Gift Card)

Retail Prize Value \$1,500. One (1) winner will receive 2 - \$500 Visa Gift Cards and 1 - \$500 Hotelgift.com Gift Card and be required to provide Sponsor with a completed IRS Form W-9 (required for winnings of \$600 or more).

Gift cards are subject to the terms and conditions of the issuer. Prizes cannot be transferred, redeemed for cash, or substituted by winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The Approximate Retail Value (ARV) of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items. Winners will be responsible for all taxes.

This Sweepstakes is open to legal residents of the United States and Prizes will only be awarded and/or delivered to addresses within said locations. All federal, state and/or local taxes, fees, and surcharges are the sole responsibility of the prize winner. Failure to comply with the Official Rules will result in forfeiture of the prize. Prior to prize distribution, proof of Social Security Number and signed image release will be required. If not provided within seven (7) days an alternate winner may be selected.

7. **Odds:** The odds of winning the prize are 1/the total number of entries received.

8. **How to Enter the Sweepstakes:** There is NO PURCHASE NECESSARY to participate in the Sweepstakes.

- a) New Charlie's Car Wash Unlimited plan customers are eligible to earn entries by signing up for a new Unlimited plan account. Ten (10) entries into the sweepstakes will be earned on new accounts for each vehicle eligible for the "\$10/month for 3 months" promotion. Vehicles added to existing accounts who qualify for the new account promotion qualify under this entry method. Each vehicle enrolled will receive ten (10) entries.
- b) Charlie's Car Wash Unlimited plan customers can earn one (1) entry each time they wash during the promotion period. One entry per day, per vehicle. Maximum number of wash entries per promotional period is sixty-one (61), per vehicle on account. Entries will be counted on July 1, 2023 for all accounts in good standing and not suspended on June 30, 2023.
- c) Vehicles enrolled in a Charlie's Car Wash Unlimited plan account in good standing and not suspended on June 30, 2023, will receive ten (10) entries, per vehicle, into the sweepstakes.
- d) To Enter Without Making A Purchase: To receive one (1) entry, enter via mail, on a plain piece of 3"x 5" paper hand print your first and last name, street address (no P.O. Boxes), city, state, zip code, month/year of birth, favorite Charlie's location, vehicle year, vehicle make, vehicle model, mobile number, and email address. Mail your entry in an envelope no larger than #10 (business-size envelope) with sufficient postage affixed, to: Charlie's Car Wash, Marketing Department, P.O. Box 856, Salina, KS 67402-0856. Mail in entries must be received by June 30, 2023 to be eligible. One entry per person. Do not mail more than one entry form in a single mailing envelope. No mechanically reproduced/photocopied mailed entries permitted. Sponsor is not responsible for lost, late, illegible, mutilated, postage-due, misdirected entries, or entries not received in time for the random drawing.

9. **Winner Selection:** The Winner of the Sweepstakes will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. The random drawing will be conducted no sooner than July 12, 2023 by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entries received.

10. **Winner Notification:** Winners will be notified by phone or email at the phone or email address provided on the Account (of record for vehicle) on or about Friday, July 14, 2023. Winners must accept the prize by email as directed by Sponsor within seven (7) days of notification. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive email account(s) or incorrect or non-working telephone numbers, technical difficulties associated therewith, or Winner's failure to adequately monitor any telephone or email account.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents"). No substitution or transfer of a prize is permitted except by Sponsor.

11. **Privacy:** By entering the Sweepstakes, you grant Sponsor permission to share your personally identifiable information for the purpose of administration and prize fulfillment, including use in a publicly available list.

12. **Limitation of Liability:** Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, camera, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of any network or wireless service, the Internet or website or any combination thereof; (e) suspended or discontinued Internet, wireless or landline phone service; or (f) any injury or damage to participant's or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Sweepstakes or download of any materials in the Sweepstakes. IN NO EVENT SHALL SPONSOR OR THE PROMOTION ENTITIES BE

Additionally, you hereby agree to indemnify the Sponsor and the Released Parties from any and all losses, damages, costs, expenses, rights, claims, demands and actions (including attorney's fees and expenses for litigation and settlement), which may be brought against any one or more of them by anyone claiming to have suffered loss or damage as a result of your participation in the Sweepstakes and/or with your acceptance, possession, use or misuse of any prize.

Sponsor and Released Parties shall not have any further liability to any participant in connection with the Sweepstakes.

13. **Disputes:** Each Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or in connection with this promotion, or any prizes awarded, shall be resolved individually, without resorting to any form of class action, and any judicial proceedings shall take place in a federal or state court within the State of Kansas.; (ii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iii) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
